STATEMENT FROM LIBERTY ACQUISITION HOLDINGS

NEW YORK, NY. – February 25, 2010 -- Liberty Acquisition Holdings Corp. (NYSE AMEX: LIA, LIA.U, LIA.WS) confirmed today that it is in discussions with respect to a potential business combination with Grupo Prisa (MCE: PRS.MC) of Spain, noting however that no definitive agreement has yet to be executed and that no assurance can be given that one will be so executed. Liberty is a special purpose acquisition corporation and as such is actively engaged in finding a suitable target business with which to consummate a business combination.
